Dear Professor Hunt:

The Landscape Architectural Accreditation Board (LAAB) at its February 22-23, 2019 meeting granted accreditation for a period of six (6) years to the course of study leading to the first professional BLA degree at Ball State University. This status is subject to review of an interim report to be submitted by December 1, 2020 and annual reports and maintenance of good standing.

The interim report should provide an update on each Recommendation Affecting Accreditation (RAA) in order to demonstrate compliance, or steps towards compliance, with the respective standard. Programs will be given up to two years to resolve their RAA(s). Upon receipt of the two-year Interim Report, the LAAB will accept that the RAA(s) have been addressed or, if not, the program will be given two more years to resolve the issues. A second Interim Report will be due to the LAAB on or before four years from the receipt of the Action Letter. If the RAAs are not successfully resolved or, in the case of longer term issues, substantial and verifiable progress has not been made at that time (after four years from the Action Letter) then the program may be moved to provisional status, it may be suspended, or in some cases the program's accreditation may be revoked.

Accreditation is awarded on a time-certain basis. The six-year period of accreditation ends December 31, 2024. Accordingly, the BLA program is next scheduled for a review during the fall of 2024.

In making its decision, LAAB considered the program's self-evaluation report, the visiting team report, and the program's response to the report.

Enclosed is a list of recommendations affecting accreditation (to be responded to in an interim report) and an Interim Reporting template. This list was developed by LAAB from the materials reviewed during the meeting.

SUMMARY OF RECOMMENDATIONS

Recommendations Affecting Accreditation

- 1. The program should be proactive in its participation in the strategic/long-range planning efforts. The desired nesting of the Department-level plan into the College-level plan into the University-level plan provides an opportunity for the program to participate in what the team heard as common interests for inter- and trans-disciplinary education and scholarship. More broadly, and over the long-term, it also presents a foundational opportunity to raise the profile and influence of landscape architecture as both a discipline and a profession (Standard 1).
- 2. The program should comprehensively clarify its learning objectives and establish a formal framework to assess the delivery of learning outcomes at the course level. This framework should include guidelines for improvement if expectations are not being met (Standard 3).
