Dear Executive Committee Members,

Charles Waldheim, a licensed architect, has been a champion of landscape architecture for nearly 30 years. When I first met Charles, over 28 years ago in 1997, we were both at the very early stages of our careers and he was serving as the Founder and Chair of the Landscape Urbanism Program and Assistant Professor of Architecture at the University of Illinois-Chicago. Charles was leading the effort, long ago, to couple both landscape and urban design strategies as a model for intellectual discourse. Charles is responsible for creating the term "landscape urbanism" which in academia and practice today is well known throughout the world.

Charles is an intellectual with a unique ability to communicate and connect with all audiences. He is one of the few leaders in landscape architecture with the true talent to passionately and effectively articulate our profession's core objectives to improve the quality of life for our communities.

His accomplishments as an advocate, educator and administrator fill more than 20 pages of a resume. A snapshot of his varied roles and remarkable contributions to our profession include:

As the **Chair of Landscape Architecture Department at Harvard University, Graduate School of Design** and as the **Associate Professor and Director of the Master of Landscape Architecture Program at the University of Toronto**, Charles has doubled the size of both programs, budgets and faculty members. This alone, in my opinion, is worthy of an honorary ASLA title! Charles is personally responsible for **growing** our profession while simultaneously making it relevant in our contemporary culture today.

Other aspects of Charles' career that have directly enlightened our profession are numerous honors, funded research, publication, conferences, public lectures, organized symposia, moderator of numerous symposia, competitions, design jury appointment and committees. This is all above and beyond his "day job" as a Director of a graduate department.

His advocacy and personal contributions have impacted **thousands** of students and practicing professionals across the country, myself included. His reach and impact extend all over the world, and at the same time, *down the street*.



I knew Charles as a scholar, author and educator at the time that he was awarded the Rome Prize in Landscape Architecture at the American Academy in Rome, and as a member of the Board of Trustees I followed his Fellowship and the work he did while at the Academy. Awarded to only two landscape architects each year, Charles was recognized as a leader in the profession by the jury, and he followed in the footsteps of such notable members of our profession as Norman Newton (one of the first), Laurie Olin, Gary Hildebrand, Tom Leader, and Walter Hood to name a few.

As Department Chair at Harvard's Graduate School of Design, Charles has worked with hundreds of students in design studios, lectures, seminars, and workshops in MLA Programs and launched new public programs in landscape architecture at the Gardner Museum, exposing diverse public audiences to the profession through exhibitions, lectures, and installations of the finest work by landscape architects. He has doubled the size of the MLA Programs as well as budgets and faculty numbers. He has recruited hundreds of incoming students into those MLA Programs, convincing them of the significance and vitality of the profession of landscape architecture.

He has lectured internationally to public, professional, and academic audiences. His writing on landscape architecture has been published and translated internationally and he regularly serves on professional design juries and advises municipalities, mayors, and media on the role of landscape architects in shaping the contemporary city. I have participated in symposia and exhibitions that he has led at the GSD and I can attest that they have attracted participants from around the world, elicited broad and significant discussions and resulted in impactful publications on current topics affecting our profession.

In closing, I strongly support his election based on his leadership role in the discipline of landscape architecture and his ongoing contributions to the professional and academic community.
