During the past twenty five years, the National Association for Olmsted Parks (NAOP) has truly been a national leader in advancing public understanding of the history and significance of Frederick Law Olmsted and the Olmsted firm's landscape legacy.

Frederick Law Olmsted National Historic Site (Olmsted NHS) and the National Association for Olmsted Parks were both established in 1980. Since then, we at the National Park Service have had many opportunities to observe and benefit from NAOP's crucial national leadership role. NAOP has mounted national conferences, created a network which it has served with various publications including a newsletter, and been a strong advocate for struggling or threatened landscapes across the country. In addition, over the years we have participated in several welcome collaborations with NAOP which have allowed us to join in its efforts to broaden public understanding of the Olmsted firm's work. 
NAOP has been instrumental to our work in Prospect Park since we began our effort to restore this Olmsted masterpiece 27 years ago. As you may know, Prospect Park was in terrible condition in 1980. Over the years, NAOP and its network of scholars, historic landscape preservationists and citizen activists have been an incredible informational resource for our staff. They have educated us on the Olmsted design philosophy and worked closely with our landscape architects to interpret the few remaining original plans and documents so that we could preserve the design integrity of this magnificent work of art.

The NAOP network has also been a great source of guidance for me as we at Prospect Park Alliance address the pressures of maintaining a park designed in the 19" century with the cultural and social needs of the 21st century. I have been able to receive and share best practices and information with other leaders of historic urban parks around the country who face similar challenges. In turn, the cities of Louisville, Newark, Buffalo and New York- to name a few- have been able to protect and revitalize their parks and surrounding communities.

Most significantly, NAOP's on-going commitment to and vigilance on behalf of the grand legacy of Olmsted landscapes has benefited the citizens of Brooklyn. For many of our residents this 537 acre oasis of woodlands, open meadows and lakes is their only access to nature. The preservation of the park has contributed immeasurably to their health and well-being.

The success of our park and so many others nationwide could not have been realized without NAOP's leadership in landscape architecture research, education, planning and design. Their work to advance the principles of Olmsted and the legacy of irreplaceable parks is never more important than today, as we struggle to preserve the last remaining open space in urban environments for children today and generations to come. The National Association for Olmsted-Parks is most deserving of this award.
