## 125th Anniversary Model Resolution/Proclamation Guidance for Chapters

The ASLA Government Affairs team has developed the following guidance to assist Chapters in securing a model resolution/proclamation celebrating the 125<sup>th</sup> Anniversary of ASLA. Resolutions/Proclamations are a great way to bring honor and attention to important issues and unique circumstances (i.e. 125<sup>th</sup> Anniversaries!). Per the instructions below, ASLA Chapters are highly encouraged to personalize the model language for their state.

## Instructions for Chapters:

- Decide if you want the resolution/proclamation to be enacted by your state legislature and/or local governments.
- Please note that the two types of clauses "WHEREAS" and "BE IT FURTHER
  RESOLVED" are interchangeable depending upon your state's preference for structuring
  a resolution/proclamation, i.e. turning the climate change clause from "Be it Further
  Resolved" to a "Whereas" clause.
- Personalize the clauses by inserting the name of your State or City in the indicated brackets.
- Personalize the clauses by adding relevant state specific examples or data.
- Insert the name of the state university(ies) program(s) in the indicated bracket.
- Reach out to the appropriate individual (i.e. Governor, state legislator, Mayor's office, city council, etc...) with your request and provide them with the draft language.
- Once enacted, thank the resolution/proclamation sponsor on social media and tag ASLA National.
- Provide the ASLA Government Affairs team (<u>governmentaffairs@asla.org</u>) with a copy of the final enacted resolution/proclamation.

## ASLA 125th ANNIVERSARY MODEL RESOLUTION/PROCLAMATION

WHEREAS, the American Society of Landscape Architects, founded on January 4, 1899, has reached the remarkable milestone of its 125th anniversary; and

WHEREAS, the 125th anniversary of the American Society of Landscape Architects is an opportunity to reflect on the profession's transformative impact on public health, safety, and welfare through the thoughtful design, analysis, management, and stewardship of the natural and built environments in [STATE], contributing to the overall well-being of its residents; and

WHEREAS, landscape architects are STEM professionals, leveraging science, technology, engineering, and mathematics knowledge to address the most pressing challenges facing its communities, fostering innovation, research, and leadership in the field; and

WHEREAS, landscape architects, as licensed professionals, have consistently demonstrated their commitment to public health, safety, and welfare by designing accessible and safe public spaces, promoting active lifestyles, and fostering resilient and sustainable outdoor environments in [INSERT NAME OF STATE]; and

WHEREAS, landscape architects, as licensed professionals, have played an integral role in shaping the economic, social, and cultural fabric of [STATE], contributing to the creation of vibrant and livable communities that enhance the quality of life for all residents.
