

FELLOWS BUSINESS MEETING



The Council of Fellows held its annual business meeting on Monday, November 9, 2015, during the ASLA annual meeting in Chicago. At the meeting, Chair Susan Jacobson, FASLA, presented certificates to the 2015 COF scholarship recipients. In addition to introducing the students, we recognized the new class of Fellows, acknowledged departed Fellows, increased the amount of COF scholarship stipends, swore in new officers, and received a summary of ASLA public relations initiatives.

SCHOLARSHIP PROCESS AND PLEDGING

At the business meeting in Chicago, the Council voted to increase the scholarship stipend amount for each the three scholarships from \$4,000 to \$5,000. In addition to receiving \$5,000, each recipient receives a one-year student ASLA membership, general registration fees for the ASLA Annual Meeting and EXPO, and a travel stipend to attend the meeting. We have heard from previous students that the opportunity to meet and network with professionals at the annual meeting is an incredibly valuable piece of the award.

The COF scholarship fund was established by the ASLA Council of Fellows in 2004 to: 1) aid outstanding students who would not otherwise have an opportunity to continue a professional degree program due to unmet financial need; 2) increase the interest and participation of economically disadvantaged and under-represented populations in the study of landscape architecture; and 3) enrich the profession of landscape architecture through a more diverse population.

FIFTH PUBLIC AWARENESS SUMMIT ATTENDED BY MARQ TRUSCOTT, FASLA

I attended the fifth annual public awareness summit, along with representatives from all of ASLA's 49 chapters, in January. Convening in Charleston, South Carolina, the purpose of the meeting was to discuss public awareness opportunities and tactics for 2016, as well as arm summit attendees with skills and resources to help raise the level of awareness of the profession within their states and regions.

National staff presentations included results of the ASLA public awareness campaign to date, the basics of public relations, ASLA's involvement with D.C.'s Adopt-a-School program, and how chapters can use social media to leverage awareness.

Four attendees discussed case studies of successful public awareness efforts as well.

Lisa DuRussel, ASLA (New York), discussed Sketch Out/Loud, a collaboration between the New York and New Jersey Chapters and Urban

Sketcher; Lucas Vannice, Associate ASLA (Washington), reported the results of his chapter's organization of PARK(ing) Day in Seattle and provided tips on working with a city's Department of Transportation. Audra Lofton, Affiliate ASLA (Georgia), shared her experiences working with University of Georgia students to create successful PARK(ing) Day installations; Matthew Wilkins, Associate ASLA (San Diego), detailed the redesign process of their chapter's website.

As Fellows of the Society we can assist in a number of ways. My ideas include:

- Hosting a sketching 'meet-up'
- Hosting a project tour
- Help organize a chapter speaker's bureau
- Write an article for your chapter newsletter, covering these two questions – Why landscape architecture? What does it mean to me?
- Sponsor a student's admittance to a professional event, state conference, or annual meeting.
