Dear Executive Committee,

It is my pleasure to nominate **United States Senator Chris Murphy** for induction as an honorary member of the American Society of Landscape Architects. As the junior Senator from Connecticut, he has been tireless in his efforts in advancing legislation to protect Connecticut's natural resources and improve public access to recreational landscapes.

Last spring, the **John D. Dingell, Jr. Conservation, Management and Recreation Act** passed with the support of Senator Murphy who was a vocal advocate for permanently reauthorizing the **Land and Water Conservation Fund**. He also included language to designate Connecticut's lower Farmington River and Salmon Brook as a national Wild and Scenic Rivers. "This is a big win for Connecticut and a testament to good old fashioned Yankee persistence," noted the Senator in his remarks to the press. Murphy first introduced the proposal in 2007 as a Representative in Connecticut's 5th district and never gave up on seeing it through to completion.

For the ten towns along these newly-designated Wild and Scenic River areas, there is now access to an additional \$100,000 per year in federal funding for invasive species removal, sedimentation and erosion control measures, construction of trail systems, implementation of recreational landscapes, and other services provided by landscape architects. In Connecticut, over 500 conservation and community recreation projects have been implemented thanks to LWCF funding, and there will now be countless more thanks to the efforts of Senator Murphy.

This past June, Senator Murphy introduced **S. 1730: Living Shorelines Act of 2019** with his colleague Kamala Harris, and he has not let the lack of action by the Majority Leader discourage him. "The Living Shorelines Act helps protect coastal communities along Long Island Sound, by sending money to towns that are working on environmentally friendly projects to fortify against future storms and rising sea levels. Senator Harris and I will work hard with our colleagues in the Senate to get this bill across the finish line," said Murphy in his December press release upon passage of the companion bill in the House of Representatives. ASLA has been a strong proponent for passage of these bills, and Senator Murphy has been a critical ally in advancing the legislation.



As a member of the U.S. Senate Appropriations Committee, he successfully extended funding for the **Highlands Conservation Act** through 2021. Thanks to initial efforts by the U.S. Fish and Wildlife Service, over 1,630 acres of biologically diverse ecosystems and aquifers have been protected in the 26 towns that comprise the region in Connecticut. State and federal grants through this program are allowing municipalities and land trusts to hire landscape architects to help preserve local forests, waterways, and open spaces, while promoting the tourism and recreational activities that are so important to economic growth

This past year, Connecticut ASLA honored Senator Murphy with our **Connecticut Olmsted Award** for his steadfast dedication to land stewardship and unwavering dedication to providing and protecting access to public spaces. Furthermore, the Senator's annual *Walk Across Connecticut has a certain Olmstedian quality that harkens back to the boyish rambles of a young Frederick Law Olmsted across the Hartford backcountry.*

Since 2016, Murphy has trekked hundreds of miles across the state on foot, in the heat of summer, meeting with constituents both in town halls as well as impromptu locations on the road. "You see Connecticut in a different way when you are walking it," Murphy said in a Hartford Courant article. "I think there's a risk in this job that you only see the feedback that comes back to you instead of going out and being proactive."

Senator Chris Murphy is committed to the critical role of the United States as world leader in climate preparedness and resilience.

He has served the public in an ascending series of elective offices from the Connecticut State Legislature to his present role as junior U.S. Senator from Connecticut. Throughout his public service, he has been a leading champion of open space conservation, outdoor recreation and education, and environmental quality, earning a lifetime score of 96% on the League of Conservations' National Environmental Scorecard.

As State Representative in Connecticut the first bill he introduced empowered local municipalities in protecting wetlands (2011).

It is my honor to write in support of the nomination of Senator Chris Murphy for Honorary Membership in the American Society of Landscape Architects. Since his election as Connecticut's junior senator in 2013, Mr. Murphy has been a strident protector of our state's natural resources, a promoter of legislation protecting access to open space and has recently emerged as a national leader in coastal resiliency and climate change legislation. As someone who has followed his tenure in the US Senate it is clear to me that his principles and actions are in complete harmony with the interests of the ASLA and as such is deserving of this honor.

Senator Murphy has co-sponsored numerous environmentally oriented legislative acts including among others:

- The Outdoors for All Act of 2019 aimed at acquiring land and water for parks and other outdoor recreation purposes through the Outdoor Recreation Legacy Partnership Program of the National Park Service.
- The Super Pollutants Act of 2019 to reduce short-lived climate pollutants,
- The **Sea Our Seas 2.0 Act of 2019** to reduce the proliferation of debris and plastic waste in marine environments,
- The Regional Greenhouse Gas Reduction Act of 2019 to establish a working group within the EPA dedicated to reducing usage of fossil fuels,
- The **Wildlife Corridors Conservation Act of 2019** to provide for the protection and restoration of certain native fish, wildlife, and plant species,
- The **National Scenic Trails Parity Act** to have New England national scenic trails be administered as units of the National Park System and
- The Wood-Pawcatuck Watershed Wild and Scenic River Act (2019) to designate certain river segments within the Wood-Pawcatuck watershed as components of the National Wild and Scenic Rivers System.

This past June, Senator Murphy was one of two senators who introduced **The Living Shorelines Act of 2019, (S. 1730),** which will protect coastal communities by funding work on environmentally friendly projects to fortify against future storms and rising sea levels.
