Dear Executive Committee and Board of Trustees.

The Illinois Chapter of the American Society of Landscape Architects is pleased to nominate **Magdalena** (**Maggie**) Aravena for the Emerging Professional Medal. Maggie is the current president of the Illinois chapter and is a landscape designer at Lamar Johnson Collaborative in Chicago, Illinois. She is driven by her experiences as a first-generation immigrant from Chile and is passionate about exploring the role landscape architecture plays in improving disadvantaged communities through education, advocacy, and collaborative design. Since her introduction to ASLA as a student at UC Davis, Maggie has demonstrated exceptional leadership and continues to make considerable contributions to the field of landscape architecture, not only in the state of Illinois but at the national level as well.

Maggie discovered landscape architecture by way of her initial interest in civil engineering. While civil engineering provided her with the scientific and mathematical foundation for *how* to mold the built environment, it was landscape architecture that allowed Maggie to explore the balance between design and science, the natural world and the built one, and express her creativity. Her love for designing spaces for people stems simply from her innate desire to help others. It was this love for the profession of landscape architecture and the desire to help others that ultimately led to her involvement in ASLA.

As a student at UC Davis, Maggie quickly immersed herself in the organization, first as the secretary, and then eventually rising to Student Chapter President. As the Student Chapter President, she was responsible for a major student fundraising effort for the new National Center on Landscape Architecture. It was also in her undergrad where she participated in her first Advocacy Day in Washington, D.C., and discovered the larger responsibility we have as professionals: that protecting the health, safety, and welfare of the public extends far beyond the physical elements of a site's design. In fact, Maggie hasn't missed an Advocacy Day since her first one in 2015. Additionally, Maggie attended multiple national conferences as a student, actively participating in the Chapter Presidents Council meetings, growing her network of professionals, and attending education sessions.

Upon graduation, Maggie easily transitioned her involvement from the Student Chapter to the Sierra Chapter. She was elected the Chapter's Secretary in 2016 while serving double-duty as the Membership Chair. At the Sierra Chapter, she instigated the very first Park-in-a-POD. Park-in-a-POD is an on-demand mobile community outreach platform that consists of easily-movable outdoor furniture stored in a PODS unit, and its purpose was to increase the

visibility of the profession and ASLA organization in Sacramento. The three-hour pop-up park created by Maggie and her Sierra Chapter team introduced over 200 people to the profession of landscape architecture. Park-in-a-POD easily translated the ASLA Mission into a tangible object that could not only be understood but appreciated by the public (and other landscape architects, too). It encouraged fellowship by bringing members together to build and facilitate the event, advocacy by encouraging partnerships not just with allied professions but also with public agencies, communication by increasing public awareness of the profession and organization, and education by encouraging career discovery for individuals of all ages. In addition to Park-in-a-POD, Maggie played a key role in the implementation of the Sierra Chapter's PARK-ing Day festivities, another prime opportunity to put ASLA's mission to work.

In addition to her heavy involvement at the local level, Maggie has always been engaged in the organization on the National level as well. While serving in her local chapter leadership roles for the Sierra Chapter, she also participated in the National Emerging Professionals and Associate Advisory Committees. Maggie was the first Emerging Professionals Liasion to the Board.

In 2017, Maggie moved across the country to join the Illinois chapter and has been a pivotal, engaged member from day one. She plunged quickly into the Chapter through a variety of committees: the Emerging Professionals, Advocacy, Public Awareness, and Membership committees, to name a few. As a member of the Emerging Professionals Committee, she helped to organize the annual Leadership Forum, playing a key role in engaging allied professions to attend the event. While on the Public Awareness Committee, she helped organize PARK-ing day. Her high level of engagement in the Membership committee quickly elevated her to Co-Chair, where she implemented a membership renewal reminder process to keep members engaged and continuously looked for ways to connect with more firms and agencies in ways that would increase support of employee ASLA memberships. She has helped educate other members, committee chairs, and elected officials about membership value. She also developed additional incentives to attract more student members. Under Maggie's leadership, the Illinois Chapter has seen the largest increase in student memberships over the past year.

As President-Elect, Maggie helped the Chapter navigate the pandemic, working with committee chairs to transition their programming and events online. During her time in this role, she also continued her pivotal role in local licensure efforts as well. Now, Maggie leads the local Illinois Chapter as President. Under her leadership, the Chapter has already begun in earnest our planning efforts for 2021. Only a few short weeks ago, she facilitated our planning retreat, where we revisited and refreshed the Chapter's strategic plan – an effort that had not been done since 2013.

In addition to her active role in Chapter committees, she has dedicated hours of participating in awards juries for both Chapter and student awards. She's played an active role on juries for Wisconsin, New York, and Prairie State Chapters. She also actively participates in IIT student award juries and critiques whenever possible.

Maggie is also keenly aware of the role advocacy plays in the profession. During her time in Illinois, the Chapter has struggled with the threat of deregulation and the loss of the Title Act. Her dedication to understanding the process, methods, and politics has resonated with other emerging professionals in the state. She has now passed all four licensure exams, an accomplishment that helps to fuel her dedication to the reinstatement of our Title Act and eventual passage of our Practice Act. She has remained a significant role-model of why young professionals should care about licensure and bridge the generational gap by educating new professionals about legislative impacts at every stage of their career.

During her time in Chicago, Maggie has continued to be involved with ASLA at the national level. She was the 2017-2018 National Associate Representative and sat on the Finance and Investments, Licensure, and Executive Director Search Committees. In 2019, she participated in the Diversity Summit, exploring diversity, equity, and inclusion in action with emerging professionals from across the nation. The information gleaned from this experience has helped to inform Maggie in her roles as Membership Chair, president-elect, and now, president of the Illinois Chapter.

Maggie combines her passion for advocacy with her passion for education and demonstrates this through the carefully-selected topics and thought-provoking dialogue that she facilitates in her sessions at the ASLA Conference on Landscape Architecture. In 2017, she spoke on a panel that explored the diverging views on design and justice, discussing the interplay of the profession, technology, and advocacy in these movements. In 2018, she participated in a Women in Leadership Roundtable that, with more than 90 attendees, was one of the best-attended PPN Live sessions ever held at the national conference. During this session, she shared her career path and lessons learned along with a standing-room-only crowd. Finally, at the 2019 Conference on Landscape Architecture, Maggie participated in a panel that explored the role of allies, advocates, and stakeholders have in closing the gender gap in landscape architecture.

Maggie demonstrated her passion for our profession early in her undergraduate studies, and she continues to find ways to elevate landscape architecture at both the local and national levels. The Illinois Chapter is not only proud of Maggie's work advocating for, educating about, and motivating others within the profession, but also with her as our president, and we are excited to see what's next for our Chapter and what's next for her. We hope you'll recognize, as we do, how valuable Maggie's presence in the profession and ASLA is and bestow upon her the Emerging Professionals Medal.

I have no doubt she will continue to do so, and I recommend her for this well-deserved recognition of outstanding service and leadership without reservation.
