It is an honor to submit my endorsement of Shawn Kelly, FASLA, for the ASLA Medal. Shawn's life-long commitment to educating landscape architecture students in sustainable and ethical site design has produced a generation of landscape architects creating spaces both ecologically and socially just.

Shawn has been a teaching faculty at University of Wisconsin-Madison Department of Landscape Architecture for over 25 years and we have been colleagues for 18 of those. The students are taught by him in four courses: grading and drainage, construction details, professional practice, and the senior capstone studio.

Shawn has a teaching style that draws heavily from his own design practice. His approach to teaching grading and drainage, just like his practice, emphasizes water conservation. This course is perhaps the most meaningful in our curriculum and our graduates practice his design philosophy throughout their own careers.

The department often hears from alumni how important Shawn's courses have been in their professional practice, both informally and through our alumni surveys. Even landscape architects who Shawn taught 25 years ago, identify him and his courses as the most influential on their design. These landscape architects are still applying

Shawn's teaching on stormwater management as an opportunity to not only address local and global water systems, but as design principles that have become part of our collective response to global climate change.

Shawn's influence on our far-flung alumni cannot be overstated. Those he has educated continue to have a lasting impact on the practice of landscape architecture.

# ASLA Medal Nomination for Shawn T. Kelly, FASLA

#### **Commitment to Education and Practice**

During the past thirty years Mr. Kelly has both worked full time at the University of Wisconsin, Madison on the Instructional Faculty and as principal in his design firm, Kelly Design Group, LLC. At the University he is mentor to every class, starting in the sophomore year, continuing through the Senior Capstone projects, and well into the graduate's careers. Shawn began a module in his Professional Practice Course that focuses on how to write and pass a law in local legislatures. He promotes an understanding of the similarities and differences between local and national politics and policies, as well as licensure defense. As both educator and mentor, Mr. Kelly has been effective in his nurturing of our professional future. In practice, Mr. Kelly has continued to produce solutions at the cutting edge of water harvesting and quality improvement, bridging practice, academia, and public awareness in a unified effort. Everyone who meets Shawn, from Client to Student, does not leave the first meeting without hearing that "the world is running out of potable water, and this is what we can do about it in this situation...."

His work with the College of Agriculture and Life Sciences at the University of Wisconsin-Madison to form the Center for Sustainable Design has placed him in the forefront of demonstrating the integrity of landscape architecture to academics and administrators otherwise unaware of the impact of the profession.

During his academic career, Mr. Kelly has also lectured widely on the importance of working with indigenous communities to create equity, justice and cultural cohesion. He has received recognition for his work and has been described as, "A Landscape Architect's Landscape Architect." He has been an active member of the Council on Educators in Landscape Architecture and presented numerous times at the annual CELA conference. Seeing issues on the horizon for the landscape architecture programs, he dedicated several years to help formulate a white paper with the ASLA Committee on Education regarding the status of education for landscape architects and STEM education.

#### **Commitment to Licensure and Environmental Advocacy**

After moving to Wisconsin, Shawn became involved in the efforts to support licensure for landscape architects. He testified before a Legislative Committee to build support for the first adoption of a Title Act. After the act became State Law, at a celebratory dinner for the law passage Shawn asked, "When are we going to go for the Practice Act?" Through his determination and steady efforts, Shawn began what became an eleven-year effort to research, write, gain support, and lobby for what became the forty-eighth Practice Act. For many years single handedly, he worked diligently to bring more ASLA members on board to lobby legislators for support to pass the law. At the signing of the law, Shawn's dedication was recognized by the Senate and House members by placing Shawn behind the Governor as he signed the bill. Shawn also received the first pen used to sign the bill.

Shawn has continued to be an active advocate for our profession nationally and regionally. Many of his students who participated in licensure lobbying efforts have continued into leadership roles in ASLA Chapters where they carry on the legacy of advocacy. His national award for Advocacy was in recognition of that work. Shawn's advocacy for water resources has taken on a new passionate level in light of rapidly declining aquifer health and extreme weather events across the globe. Shawn's influential voice on the urgent need to manage water wisely has inspired generations of landscape architects.

#### Commitment to the Profession and ASLA

Shawn's service to ASLA began over thirty years ago with his participation in the ASLA San Diego Chapter and has continued ever since. Along with his advocacy efforts, Shawn served as State Chapter Secretary and then President in the 1999 centennial year of ASLA. During his tenure as Chapter President, he hosted the first tristate ASLA regional meeting in Madison, implemented the strategic planning methodology he helped prepare, and worked with ASLA National for the events and products for ASLA National's Centennial celebration.

Shawn continued his leadership by serving two terms as the Wisconsin Chapter Trustee. He was never satisfied with the normal participation. He delivered a speech to the Board encouraging them to authorize the spending to renew and improve the ASLA Headquarters building in Washington, DC. resulting in agreement to support the project. Shawn served as a mentor to new Trustees, encouraging them to find their passion and voice. He spoke on issues of importance at the national level, including strengthening accredited landscape architecture programs, inspiring emerging professionals, and following good fiscal management. Shawn also produced a useful orientation document - the "Complete Idiot's Guide to being Trustee" for use by new Trustees to empower them to perform the important work of guiding ASLA's policies and work.

Serving as Vice President of Membership, Shawn worked with a consulting team to evaluate ASLA's membership, with the goal of reaching more landscape architects and finding new members. His diligent and honest evaluation of the team's work led to an improved result and membership strategy. During Shawn's time as a Vice President, he, along with the Executive Committee and Trustees, navigated complex issues related to managing the SITES initiative with the Lady Bird Foundation/ University of Texas and the Botanic Garden as well as complex financial discussions. Shawn clearly articulated the responsibilities inherent in each level of leadership commitment and developed an understanding of the roles and responsibilities of volunteer leadership at the national level. As outgoing Vice President Mr. Kelly was asked to write "The Complete Idiot's Guide to being a Vice President." He also wrote, "The Complete Idiot," a guide to those interested in the Presidency of ASLA.

Mr. Kelly also served as a two-year representative to the International Federation of Landscape Architects (IFLA). He was the first representative to file a report of his meeting with the ASLA and noted systemic issues with IFLA governance and dues related to ASLA. Shawn's critical evaluation of the situation led to a frank discussion and ASLA stepped back from the IFLA body until concerns, with income generation, dues equity, etc. were addressed. This clear message relayed through Shawn's observations led to changes in IFLA and opened the discussions for a future agreement regarding ASLA's participation which resumed in 2021.

Mr. Kelly also represented ASLA at Habitat Three: The United Nations third meeting on the evolution and trends in cities. He returned to ASLA with a report about the New Green Agenda product of the meeting, and a review of global awareness of the work of ASLA. The presentations opened up new dialogue about ASLA and the professional perspective of landscape architects.

Shawn was elected President of ASLA in 2019 and was the first incoming President to receive the President's medal at the meeting where he was sworn in to become the President. This was in recognition of his work for the Society and the profession at large. Beginning at his first meetings he opened a new level of discussion and openness to change. He asked the Executive Committee to meet with ASLA staff to coordinate goals, accomplishments, and concerns. The results of this were new opportunities to collaboratively review the ASLA Annual Operating Program and identify opportunities for greater impact. The Executive Committee, under Mr.

Kelly's leadership, revised several project areas and took a completely fresh look at the allocation of resources and ASLA's organizational leadership. The search for a new ASLA CEO began during Mr. Kelly's tenure.

His leadership and nurturing of fellow leaders in his Executive Committee inspired impactful changes that allowed ASLA to emerge as a stronger organization. Those who worked so closely together in the immense efforts of Mr. Kelly's term as President realized the benefits of teamwork among leaders to realize several major goals. Some of the specific accomplishments of the leadership follow.

- Initiation of a comprehensive strategic plan for ASLA.
- Development of more open dialogue and discussion at governance meetings
- Selection of the Search Committee to find and hire a new CEO and develop a prospectus for the Society including well defined roles and responsibilities for the CEO and volunteer leadership.
- Issuance of an RFP for a new and improved web presence for ASLA.
- Creation of a stronger alliance with a managing professional licensing group and support for state and national scale licensure advocacy.
- Opening discussions to institute free membership for landscape architecture students.
- Writing and gaining approval of the ASLA Zero Tolerance for Discrimination Policy passed by the Board of Trustees
- Exploration of new sources of revenue for ASLA to address business scenarios of the future and removal of barriers to e-commerce solutions for membership renewal
- Diversification and improvements to the ASLA Fund and developing alliances and opportunities for future collaborations to further ASLA goals


