To Members of the Executive Committee and Board of Trustees:

On behalf American Society of Landscape Architects Florida Chapter, we are honored to nominate Diana Ferguson for Honorary member status in the society. Diana has been a godsend to our profession since she was hired as our lobbyist in 2011. She serves not only as our lobbyist but as a key advisor and counselor for bills and potential threats to our profession. Diana joined the firm of Rutledge Ecenia in January 2011 as an attorney and lobbyist. Her practice is concentrated in the areas of environmental and administrative law, regulated industries and government relations. She currently provides governmental advocacy services for several clients, including businesses, local governments, associations, and non-profit organizations. Prior to joining the firm, Diana provided legislative counsel to the Florida Association of Counties. In that capacity, she lobbied numerous environmental issues as well as other local government issues.

Diana was pivotal in the structuring of our Political Committee in 2013 after the passing of HB 569. This bill prohibited all of Florida's Committees of Continuous Existence (CCE) from accepting contributions. This prohibition was led by the Division of Elections (DOE) of the Department of State (DOS). Diana led the effort of converting our Committee of Continuous Existence (CCE) to a Political Committee (PC). She also drafted the Bylaws for the Friends of Landscape Architecture Political Committee (FLAPC) https://www.100fla.org/ and began her role as the permanent Secretary and Treasurer for the FLAPC. FLAPC is certified and regulated by the Florida Department of State. The conversion of the state CCE's to PC's in 2013 allowed for unlimited contributions. With Diana at the helm, the FLAPC provides the resources necessary to promote and advance Landscape Architecture in Florida. As a statutorily regulated profession, Florida's Landscape Architects are recognized as state registered professionals. This distinction results from the Florida Legislature's recognition of the practice of Landscape Architecture. Contributions are recommended by Diana and approved by the Board of Directors as provided in the Bylaws. Members of FLAPC help to provide the necessary resources to promote and advance the governmental affairs interests of the profession. Florida Landscape Architects are privileged to enjoy the statutorily conferred professional status of state registered design professional, which is the hard-earned result of the Florida Legislature's recognition of the importance of our profession.

Each year, Diana's goal is to support many of our ongoing allies, who represent a bi-partisan mix of state House and Senate leaders that have been champions for the profession. These relationships are a direct result of her hard work throughout the state. We are also able to forge new relationships each year with the numerous other professional organizations and lobbyists that she collaborates with. These organizations include the International Society of Arboriculture, Florida League of Cities, Florida Nursery, Growers and Landscape Association, Florida Engineering Society, Florida Building Commission, and the Florida Department of Transportation as well as many others. This has become even more important with term limits, as we have a new class of legislators every two years, most of whom are not familiar with our profession. Landscape Architects know the importance of educating these legislators and the public on a regular basis. Case in point, the 2019 Florida Deregathon that Governor DeSantis organized for all 23 of the Florida Professional Licensure Boards. Diana was a key liaison for us as we positioned ourselves to support and offer technical advice to our Florida Board of Landscape Architects. Deregulation,

Sunset, Consultant Competitive Negotiation Act (CCNA), Highway Beautification and even Tree bills are prime examples of items that Diana monitors as numerous bills are presented to the Florida House and Senate. Another example is SB518 in 2021 that we appropriately labeled 'The Tree Bill'. This was a broad sweeping bill to allow mass tree removals in preparation of major storm events. Diana worked with the Florida ISA lobbyist and the Florida League of Cities to craft language in response to this bill. This was a true partnership to correct the bill language that could have resulted in mass litigation throughout the state.

Many of our legislative champions, including Representatives and Senators, but also cabinet officials such as the Chief Financial Officer, spend time with ASLA FL members at the Annual Conference and at other events, including webinars and political events organized by the Friends in coordination with various chapters. Diana's dedication to orchestrating these monumental efforts are not only good for Florida Landscape Architects but for the entire profession. Our profession constantly benefits from the political activity undertaken by the Friends. Diana has orchestrated strategic meetings to not only have our voice heard but to help us avoid landmines presented in bills presented throughout the committees and sub-committees on the House and Senate floors. Legislators and legislative staff routinely look to ASLA leaders and consultants as subject matter experts in legislation affecting landscape architecture, particularly as to the effect of deregulation proposals, as well as environmental issues such as water quality and tree protection ordinances. Her tireless effort has elevated many of these legislators to speak on our behalf during session meetings; as well as on social media accounts supporting such things as our 1.5% allocated to highway beautification. She's also been influential in setting up gift presentations of prized photography from artists such as Clyde Butcher and Steve Vaugh. These gorgeous prints sit proudly in the offices of legislators and one of the first things discussed with their guests is the profession of Landscape Architecture.

Diana is an invaluable resource to our Chapter and her influence has no boundaries. Our annual conference garners many visitors from out of state. Some of which have participated in our monthly Government Affairs Meetings to disclose their hurdles with their own local state legislators. These ASLA members have heeded many of Diana's recommendations to use in their own government legislative battles. On behalf of the ASLA Florida Chapter, it has been an honor to serve alongside Diana. She has promoted and lead the protection of our profession on so many levels. Please accept this nomination of Diana Ferguson for ASLA Honorary Membership.
