The Council of Higher Education Accreditation (CHEA) had an observer attend the meeting.

Other items discussion items were the status of the online annual reporting process for accredited programs, implementation of the policy on public information, LAAB's application for renewal of recognition with CHEA and preliminary thoughts on preparing for a review of the accreditation standards.

Currently, LAAB accredits at least one program at 69 institutions in the United States. There are 51 accredited MLA programs and 44 accredited undergraduate programs. In 1990 there were 37 undergraduate programs and 21 MLA programs.
