It is my pleasure to nominate Lorraine Davis of the University of Oregon for Honorary Membership in ASLA, in recognition of her remarkable participation in the accreditation process for landscape architecture programs over the past twenty five years. As a member of the Roster of Vising Evaluators (ROVE) for the Landscape Architecture Accreditation Board (LAAB), Lorraine has served as the administrator for visits to over 25 degree programs. For those unaware of the process, a ROVE team is usually made up of three members: an academic from landscape architecture, and practitioner from landscape architecture, and an academic administrator from any background. Lorraine has been filling this position of odd-man-out for a quarter of a century.

Lorraine and I first worked together when we were assigned to the same accreditation visit in the fall of 2012. We spent four days with other colleagues visiting a small landscape architecture program that was under review for initial accreditation. Each member of this team had devoted time to study the self-evaluation report that the administrators, faculty, staff and students had prepared prior to our arrival. ROVE visits include meetings on campus all day and writing the preliminary report in the evenings. It is intensive work and involves long days away from home and family and more hours at home before and after the visit working as well. This was only my second accreditation visit and I was impressed to learn that Lorraine, with no other connection to landscape architecture, had been doing one of these visits every year since the late 80's. That's approximately 100 days devoted to our profession's accreditation visits, excluding the preparation and follow up time involved with each visit.

During that visit, Lorraine and I realized that our paths had crossed previously. I was a student at Oklahoma State University in 1989 and Lorraine was on the ROVE team visiting our program there for accreditation review. I do not remember her from that visit, but imagining her there prior to the start of my career reinforced to me, a mid-career professional, how much time she had committed to landscape architecture education.

Lorraine Davis is exceptional in her chosen profession of academic administration. Her accolades are many and her curriculum vitae is lengthy, and reflects a career rich with accomplishment. She is an established scholar, administrator and teacher. She received her Ph.D. in Health Education with special preparation in statistics, research, curriculum and special population from the University of Oregon. In 1990 she began her lengthy successful positions in the Provost Office at the same university. She has held many high ranking academic administrative positions including Interim Athletic Director in 2009. She is presently the Special Assistant to the President and Provost at the University of Oregon. That Lorraine has been willing to bring the same level of professionalism and commitment to ASLA while accomplishing so much in her own field makes her contributions that much more remarkable.

Landscape architecture education is better because of Lorraine Davis. She is very aware, far more so than many of us, of the standards that LAAB maintains and measures our academic institutions against. She continues to serve landscape architecture in this capacity of academic administrator on ROVE visits and looks and sounds like one of us. She deserves to be recognized for her generosity and commitment to the betterment of our education programs.

Thank you for your consideration of this nomination. I hope you will acknowledge Lorraine Davis' service to our society, our profession, our academic programs and our students with Honorary Membership in ASLA.
