The purpose of the group is to collectively identify and promote policies and best practices for transportation planning. Current topics being discussed include:

- Performance-based transportation planning
- System resiliency and climate-change adaptation
- Integrating connected and autonomous vehicles into the transportation network
- Innovative public engagement
- Improving regulations
- Promoting Federal transportation funding reauthorization

All of these topics are important aspects of practicing landscape architecture in the transportation industry, and we're very excited to have a seat at the table as these issues are being discussed.

TRB Call for Posters

The Transportation Research Board (TRB) Standing Committee on Landscape and Environmental Design (AFB40) invites submissions of your work as part of a landscape and environmental design poster session at TRB's Annual Meeting in Washington, DC in January 2020.

Deadline: September 16, 2019

Please submit your abstract for consideration for presentation at the TRB Annual Meeting, Landscape and Environmental Design (AFB40) poster session. Topics that emphasize the following, as they relate to transportation and environmental design are a priority for AFB40:

- Energy and Sustainability design, policies, and practices to protect the planet.
- Policy needs related to the built environment that should be developed prior to full adoption of autonomous vehicle technology.
- Resilience and Security preparing for floods, fires, storms, and sea level rise.
- Transformational technologies that will change how transportation environments should be retrofitted or rebuilt.
- Design to serve growing and shifting populations.

AFB40 also welcomes completed and on-going projects from broad landscape and environmental design areas such as Green Streets, roadsides for pollinators, Complete Streets, transportation design impacts on Main Streets, landscape design to safeguard the public, and art in transportation, as they relate to the scope of this committee. Poster sessions run for approximately 3 hours in the morning (9:30 a.m. to noon), afternoon (2:30 p.m. to 5:30 p.m.), or evening (7:30 p.m. to 9:30 p.m.), depending on how they are scheduled by TRB.
