Meeting Notes

1. Welcome and Introductions

- 2. Old Business
 - a. ASLA HALS Map of HALS Documentation across the nation. This interactive map is updated quarterly. There are over 700 sites with HALS documentation to date. If you do not see the map at the bottom of the following page, try a different browser (e.g. Explorer, Firefox). In addition to the map, the <u>list</u> of documented sites is also online. <u>https://www.asla.org/ContentDetail.aspx?id=37489</u>
 - b. Chris Stevens presented a 60-minute ASLA Online Learning presentation Wednesday, August 30. Ann Mullins introduced the session, titled: The Historic American Landscapes Survey (HALS): An Introduction to HALS and the Short Format Historical Report. Examples of HALS baseline and mitigation documentation prepared by professional landscape architectural practitioners were shared along with examples of landscape architectural university programs using HALS to teach site documentation to students. Anyone may prepare HALS documentation for the open ended collection to promote preservation, and this presentation explained how to prepare a HALS Short Format History for submission to the annual HALS Challenge competition.

c. ASLA and the Heritage Documentation Programs hosted a workshop to develop guidelines for digital photography for the Historic American Buildings Survey, the Historic American Engineering Record, and the Historic American Landscapes Survey (HABS/HAER/HALS). The workshop was held at the ASLA Headquarters on November 2 & 3, 2017. We were joined by large format photographers and staff from the Library of Congress and NARA, who also have significant experience in curating born-digital collections and whose ultimate responsibility is to preserve the documentation and make it accessible. The agenda focused on three discussion topics: capture, processing, and archiving. Currently digital large-format photography is not accepted as stand-alone photographic documentation in the HABS/HAER/HALS Collection. We will be developing guidelines for assuring that large format digital photography is archival, verifiable, and unaltered.

- d. HALS is developing a project to document National Recreation Trails, using the historic John Muir Trail as a prototype to support a potential NHL nomination. The John Muir Shelter at one end of the trail was recently listed on the National Register. The Sierra Club will pay for the large format photographs. A history will also be prepared along with a GIS story map.
- e. Helen Erickson reminds everyone that the 2018 Alliance for Historic Landscape Preservation (AHLP) Conference will be held in Tucson, Arizona next year, March 15-17, 2018. Local historic landscapes will be featured from the Prehistoric to the Modern. This will provide a unique opportunity for the Arizona HALS Chapter. <u>http://azhals.org/</u>

The AHLP is a binational organization (US and Canada), and Tucson will provide a window into Mexican and Native America sites and opportunities for partnership and collaboration.

3. <u>New Business</u>

- a. HALS at the ASLA EXPO ASLA Central had a separate area called "PPN Live" for anything Professional Practice Network-related, such as HALS.
- b. HALS Coordinator Annual Report (Chris Stevens)
 - i. Did you meet on HALS business with your Chapter Executive Committee? 63% responded yes
 - ii. Is your HALS program included in your Chapter Executive Committee? 88% responded yes (this is not required; however, we recommend that chapters include the HALS Liaison on the Executive Committee as an unofficial, additional member)
 - iii. Does your Chapter Executive Committee support your HALS program? 100% responded yes; excellent example is the Northern California Chapter's support of HALS through the HALS Heroes Initiative's grants (see <u>The Field</u> for more information)
 - iv. Do other ASLA members in your chapter participate in your HALS program? 63% responded yes; one effective method to get other members involved is to form a committee or to work with students and professors
 - v. Did your HALS program meet with your State Historic Preservation Officer this year as an advocate of historic landscapes and HALS documentation? 31% responded yes. Education sessions on HALS and historic landscapes at chapter annual meetings and other events: e.g. the Rhode Island SHPO conference; as part of the Arizona Heritage Conservation Courses (Helen Erickson landscape architects talk to students about historic landscapes in related classes, like analysis, and get more students interested in heritage); include someone from your SHPO on your HALS committee like in Vermont.
 - would it be beneficial to your HALS program if the Secretary of the Interior included Historical Landscape Architects on the federal list of qualified historic preservation professionals? – 100% responded yes. This bureaucratic process has moved way too slowly. It is time for ASLA as an organization to step in as an

organization and poke the NPS for a response. The NPS staff member who has been heading up this process reported that he had been pulled from it during much of 2017 to work on other agency priorities but should resume with guiding the final draft to publication in the Federal Register in 2018. He also warns that it is not the best political time to move forward with anything that may be perceived as regulation.

- vii. Did you present a HALS education session for the ASLA members in your chapter? – 16% responded yes. CA Southern California invited Janet Gracyk from the Northern California HALS Chapter to lead a HALS training session at the Virginia Robinson Gardens in Beverly Hills this spring.
- viii. Did you include an education session on HALS and historic landscapes at your chapter annual meeting? – Only 10% responded yes. Many chapters do not have annual meetings. NY Upstate gave a HALS presentation as an intro to another historic preservation CEU session.
- ix. Did your HALS program meet with or make presentations to other potential partner agencies or groups, such as a Historic Preservation Commission, an AIA chapter, a garden club, etc., this year as an advocate of historic landscapes and HALS documentation? 42% responded yes. CA-Sierra will be meeting with the UC Davis campus historian and library archivist. CA Southern presented the Laguna Beach HALS CA-123 documentation to the historical society and the city council. CO/WY presents a HALS session to the Colorado Preservation Inc. annual meeting every other year. NY Upstate staffed a HALS booth at the NY SHPO conference. Rhode Island presented on their 2016 HALS Challenge entry Wilcox Park HALS RI-1 at their annual SHPO Conference.
- x. Were there submittals from your chapter to the 2017 HALS Challenge, "Documenting City or Town Park(s)"? – 37% responded yes. For those folks that began an entry but did not complete it, HALS accepts any properly-prepared HALS documentation all year long regardless of the annual HALS Challenge theme.
- xi. Did your chapter HALS program participate in HALS documentation this year? 52% responded yes. Alabama also prepared HAER documentation.
- xii. Please tell us how ASLA can better support your chapter HALS program.–Lobby Congress to fund HALS, but bad political climate. Provide funding for the HALS liaison to attend the annual ASLA meeting. Increase visibility.
- xiii. Do you have any other comments, suggestions, recommendations or questions regarding the HALS program? – Develop a checklist of the HALS responsibilities and expectations along the lines of those shown on: the <u>ASLA HALS webpage</u>. Ask for chapter HALS website to be hosted on chapter website. Promote HALS documentation through articles, websites, and conferences and meetings.
- c. The 2018 HALS Challenge Theme will be *Memorialization*, *Remembering the Great War*. This theme honors the centennial of the end of World War I, the Great War. Not only were traditional monuments constructed across the country following the armistice, but "living memorials," which honored the dead with schools, libraries, bridges, parks and other public infrastructure were designed to be both useful and symbolic at the same time. Commemoration website <u>https://www.theworldwar.org/explore/centennial-</u> <u>commemoration</u> for subject ideas or perhaps you know of another monument, park, or public institution that is not well known. These sites are in all areas of the country. We challenge you to find them and document them. (**2017 HALS Challenge Brochure follows these notes**)

- d. The theme for the 8th annual HALS Challenge was Documenting City or Town Parks in keeping with the 2016 National Park Service centennial and the FIND YOUR PARK campaign. Find Your Park is about more than just national parks! It's also about local parks and the many ways that the American public can connect with history and culture and make new discoveries. With more than 80% of Americans living in urban areas, urban parks are becoming more important than ever. Again *LAM* graciously provided full page ads for the 2017 HALS Challenge in the April and May issues. HALS received 27 entries from 15 states.
 - Announcement of 1st, 2nd, and 3rd place prizes, a brief description of each project, and presentation of certificates. No one from the winning teams were present at the meeting. (Press release announcing the winning entries and all 27 entries follow these notes)
- 4. Other Business / Open Discussion

Tally of donated HALS Documentation for the past year: *766 sites documented since HALS was created in 2000 (with 50,000 sites documented across HABS, HAER, and HALS); *30 donated or mitigation HALS records were transmitted in 2017 (this tally does not include 2017 HALS Challenge entries);

*Current HALS Office Projects - Continued World War I cemeteries documentation: Completed documentation of Meuse-Argonne American Cemetery and Memorial (80 drawings sheets, large-format photographs, substantial historical reports) and wrapping up documentation of Aisne-Marne American Cemetery and Memorial. Completed field work for documenting the Tidal Basin in Washington including its 2 miles of seawall and the surrounding landscape of cherry trees and monuments. Now finalizing the drawings, historical report, and photographs.

The 2017 HALS Challenge 1st place recipient Lee Park [Emancipation Park] HALS VA-78 would be a good subject for a *Landscape Architecture Magazine* (*LAM*) article. Paul will suggest this to Brad McKee. Tina Bishop suggested that we propose a HALS Documentation Workshop for the 2018 ASLA Annual Meeting and EXPO in Philadelphia. ASLA Workshops are ticketed events that give attendees the opportunity to learn how to navigate and problem-solve from experts in the field.

Barbara Wyatt suggested that she could contact NR coordinators in SHPOs about the WWI memorials in their states. She could bank on the captive interest with the upcoming anniversary to send the coordinators a question about WWI memorials in general. She asked that the HALS office provide her with a statement about the next HALS challenge and a link to share.

Barbara Wyatt thought it was a great idea for the NY-Upstate ASLA HALS liaison to support and staff a HALS booth at their statewide SHPO preservation conference. The HALS office provided HALS brochures and other printed materials. This is a great way for a SHPO to get to know HALS and HALS Liaisons. Booths must be rented, so funding is needed. We should ask NY Upstate to prepare a "how to" on how they obtained funding for the booth and a "promo" of why this was a great way to educate the SHPO and historic preservation professionals.

Barbara Wyatt suggested preparing a brief set of instructions on inserting HALS documentation into a National Register nomination form. She could prepare a working draft. California might be a case study for this strategy. She would work through her contact at the CA SHPO to reflect the fact that each state has slightly different procedures.

Each year all HALS Subcommittee Meeting attendees are invited to gather after the meeting for a dinner at a local restaurant. This year's location was at the Bonaventure Brewing Company on one of the plazas of the historic mid-century modern Westin Bonaventure Hotel designed by architect John C. Portman Jr. and built 1974-76. The dinner was preceded by a walking tour of the historic mid-century modern Union Bank Plaza HALS CA-119 across the street, designed by Garrett Eckbo. http://www.loc.gov/pictures/item/ca4198/

Documentation of the Lovelace Garden Designed by Isabelle Greene by Stephen Schäfer

Please check out this new beautiful book produced with the HALS Documentation of the Harold S. Gladwin Residence (Jon B. and Lillian Lovelace Residence) HALS CA-129 - the renowned California Regionalist Garden that inspired landscape architects worldwide. It contains 144 pages with 34 full page color photographs and an insightful biography of landscape designer Isabelle Greene, FASLA. The Lovelace swimming pool, which involved some difficult technical issues to complete, was a major innovation at the time, drawing considerable attention to Greene's work through articles in the Los Angeles Times and Sunset Magazine. It also inspired subsequent imitation in the 1980s and 1990s. Along with Thomas Church's Donnell pool, the Lovelace pool is one of the most frequently photographed icons of California landscape design. Laguna Beach and the Greenbelt: Celebrating a Treasured Historical American Landscape by Ronald Chilcote

Please check out this richly-illustrated book produced from the HALS documentation of Laguna Beach, California (HALS CA-123). It was recently published and is available for purchase on Amazon. This book celebrates Laguna Beach and its greenbelt, which have been designated a historic American landscape by the National Park Service, Department of Interior, and presents the nomination documentation that is housed in the Library of Congress. It is dedicated to the generations of devoted people responsible for shaping the city's character and traditions. The HALS documentation was transmitted to the Library of Congress in June 2016. The genesis of this project lies in a visit to Laguna Beach by Noel Vernon, professor at Cal Poly Pomona, on August 10, 2009. Vernon was the ASLA coordinator for HALS and introduced the program to Ann Christoph, Vonn Marie May, Ted Wells, and Tom Osborne. At that meeting Christoph suggested nominating the city of Laguna Beach and the Laguna Greenbelt as a Historic American Landscape. The historical report would emphasize the fact that the dramatic and scenic landscape had been the basis of the development of Laguna Beach as an art colony, with a tradition of environmental awareness and protection, and ultimately as a center of citizen-generated landscape preservation.

The HALS historical report was discussed for years and was well received, but it was not acted upon until Ron Chilcote organized a committee that met for the first time on March 9, 2015. The group agreed that the Greenbelt, the legacy of plein air painting, the seascape and Bluebelt, and Laguna Beach as a special place all pointed to a need to identify the history and effect of this unique landscape: to describe its characteristics, document its importance, and record its past so that present and future generations would recognize its significance. With knowledgeable and enthusiastic members, the committee coalesced to produce the HALS historical report.




Q1 Did you meet on HALS business with your Chapter Executive Committee?


Q2 Is your HALS program included in your Chapter Executive Committee?


Q3 Does your Chapter Executive Committee support your HALS program?


Q4 Do other ASLA members in your chapter participate in your HALS program?



The Historic American Landscapes Survey (HALS) was created in 2000 as a federal program to document historic landscapes in the United States and its territories. Documentation is critical to preserving these significant sites for the benefit of future generations. Like its companion programs, the Historic American Buildings Survey (HABS) and the Historic American Engineering Record (HAER), HALS produces written and graphic records used by educators, land managers, and preservation planners as well as the general public. The National Park Service (NPS) administers the planning and operation of HALS, standardizes formats and develops guidelines for recording landscapes, and catalogs and/or publishes the information when appropriate (www.nps.gov/hdp/standards/halsguidelines.htm). The American Society of Landscape Architects (ASLA) provides professional guidance and technical advice for the program through its Historic Preservation Professional Practice Network. The Library of Congress (LOC) accepts and preserves HALS documents, furnishes reproductions of material, and makes records available to the public (www.loc.gov/pictures/collection/hh/).

Results of the 8th annual HALS Challenge were announced at the HALS Meeting of the Los Angeles ASLA Annual Meeting and Expo on Saturday, October 21, 2017. Congratulations to the winners! Sponsored by the National Park Service, cash prizes were awarded to the top 3 submissions. This challenge resulted in the donation of 27 impressive HALS short format historical reports and a few measured drawings and large format photographs to the HALS collection.

Not only were traditional monuments constructed across the country following the armistice, but "living memorials," which honored the dead with schools, libraries, bridges, parks and other public infrastructure, were designed to be both useful and symbolic at the same time. You may browse The World War I Memorial Inventory Project website http://ww1mproject.org/ and the National WWI Museum and Memorial Centennial Commemoration website https://www.theworldwar.org/explore/centennialcommemoration for subject ideas, or perhaps you know of another monument, park, or public institution that is unrecognized. These sites are in all areas of the country, often hidden in plain sight. We challenge you to find them and document them. Short format histories should be submitted to HALS at the NPS no later than July 31, 2018 (c/o Chris Stevens, 202-354-2146, Chris_Stevens@nps.gov). Sponsored by HALS, cash prizes will again be awarded to the top three submissions. Results will be announced at the Philadelphia 2018 ASLA Annual Meeting and Expo during the HALS Meeting.
