Meeting Notes

- 1. Introductions
- 2. Old Business
 - a. Paul Dolinsky updates:
 - i. Status of the Secretary of the Interior's Historic Preservation Professional Qualification Standards. The NPS Solicitor's Office has released the document with no structural issues. After minor refinements, the document should be released in the Federal Register in the near future. A letter-writing campaign may certainly help accelerate this effort once David Vela is confirmed as Director of the National Park Service likely by the end of the year.
 - ii. Efforts to develop guidelines for digital photography for the Historic American Buildings Survey, the Historic American Engineering Record and the Historic American Landscapes Survey (HABS/HAER/HALS) are progressing. HDP is currently working to develop a method for receiving and storing the extremely large digital files that digital photography will entail.

iii. Please explore our newest online Heritage Documentation Programs exhibition, Hurricanes Irma and Maria: Selected Damage and Ongoing Threats to Cultural Resources.

The interactive story map explores the paths of these two hurricanes, the impacted cultural sites of Florida, Puerto Rico, and the US Virgin Islands, and existing HABS/HAER/HALS documentation for them. The group agreed that this should be pitched to LAM as a potential article.

iv. Congress has decided to recess until after the mid-term elections, so NPS Director nominee David Vela's October Senate hearing has been postponed. They are hoping to reschedule it for November 14.

b. Helen Erickson / Arizona updates:

- i. Gina Chorover (and Helen Erickson) stepped down as HALS Liaison for Arizona in August. They have been replaced by Caryn Logan Heaps (and Steve Venker) from the north of Arizona. Northern involvement will help spread interest in HALS.
- ii. Helen Erickson, Gina Chorover, Robin Pinto, and Steve Grede met with Arizona's new SHPO Kathryn Leonard to discuss how to increase HALS and Cultural Landscape Preservation across the state. The SHPO had no idea that HALS documentation existed for Arizona sites. Steve Grede has developed a cloud based GIS app to document historic Streetscapes. It was featured in the Foreground section of the August 2018 issue of LAM, pages 46-54.
- iii. Helen Erickson attended the National Alliance of Preservation Commissions' (NAPC) biennial FORUM in Des Moines, Iowa, July 18 to 22, 2018 and was part of a streetscape presentation there with Barbara Wyatt and Steve Grede and has seen positive change with landscape preservation in Tucson as she and others have increased historic landscape awareness with her local governments and preservation commission with HALS documentation. Barbara Wyatt sees this as an era of cultural landscape appreciation by every organization. The National Trust is giving a full-day landscape workshop at its upcoming meeting.
- iv. Helen Erickson attended the Preserving the Historic Road Conference would be held September 13-16, 2018 in Fort Collins, Colorado. Relationships have been established with Departments of Transportation.

c. Chris Stevens updates:

i. RI HALS Liaison, Elena Pascarella reports: Rhode Island's growing interest in a landscape survey initiative is being spearheaded by Brent Runyon, Executive Direction of the Providence Preservation Society (PPS). Other members of the survey initiative group include Rachel Robinson, Director of Preservation - PPS, Karen L. Jessup, PhD. educator and author, Kaity Ryan, Deputy Chief of Staff - Preservation Society of Newport County (PSNC) and Jim Donahue, Curator of Historic Landscapes and Horticulture - PSNC), Joanna Doherty, Architectural Historian- RI Historic Preservation and Heritage Commission and Elena M. Pascarella, RLA, ASLA - Landscape Architect and RI HALS liaison.

Providence is experiencing preservation pressure from a new wave of development, such as the new transportation hub planned for a site on the historic McKim,

Meade & White State House grounds. The city of Newport is also experiencing preservation threats as large estates are being purchased and subdivided or transformed into condominiums. PPS and PSNC are jointly spearheading this effort, and both groups are funding a Historic Landscape Fellow, Jennifer Robinson, who has been hired by PSNC to initiate the work on this RI Historic Landscape Survey. Ms. Robinson is a graduate of the University of Rhode Island and served previously as a special collections assistant with the Newport Historical Society. Ms. Robinson will be preparing a methodology for identifying, cataloging and evaluating threatened landscapes. The long-term goal of the survey is to initiate an online digital inventory of historic landscape properties throughout RI, but the initiative will begin with the cities of Newport and Providence, RI.

- ii. The NPS HALS Office is completing documentation of historic Franklin Park and the John Paul Jones Memorial in Washington, DC for the National Mall and Memorial Parks. The John Paul Jones Memorial will be an addition to the Tidal Basin documentation we completed last summer.
- iii. David Driapsa brought The NATIONAL PARK SERVICE LEGACY ACT OF 2017 to attention of the HALS Subcommittee. It has stalled in Congress with no action since it was introduced in the Senate in March 2017. The Pew Charitable Trusts is leading the Restore America's Parks Initiative campaign. The backlog of deferred maintenance in our national parks affects historic landscapes that are under federal stewardship and this issue will be of interest to ASLA HALS and HP-HPN members, whose voices across the nation are needed in this advocacy program. ASLA national is a signatory on the letter to Congress, in addition to four ASLA state chapters (Arizona, Florida, Tennessee, and Texas). Please ask your ASLA Chapters to sign on. Folks agreed that ALL chapters should write support letters ASLA Government Affairs should encourage this.

Update: In July 2018, a new compromise bill, the Restore Our Parks Act (S. 3172), was introduced in the Senate. The new bill kept the best policy components of the National Park Service Legacy Act, but brings more people to the table to support parks legislation. For example, the Restore Our Parks Act has 33 cosponsors despite only being introduced in July, while the Legacy Act has 21 cosponsors since being introduced in March 2017. For the first time, Rep. Francis Rooney is a cosponsor on parks legislation - he cosponsored the new consensus bill in the House, the Restore Our Parks and Public Lands Act (H.R. 6510).

- iv. In July, the HALS Subcommittee discussed encouraging HALS Liaisons to reach out to their local Preservation Commissions to spread the word about HALS. Barbara Wyatt offered to facilitate a meeting between Paul Dolinsky, Chris Stevens, and Erik Hein Executive Director of NCSHPO in Washington, DC. There could also be a HALS presentation at the NCSHPO annual meeting in March 2019. It could showcase documentation pertinent to smaller cities that are most represented at these meetings.
- v. The HALS Subcommittee has discussed CEUs during our last few quarterly calls sharing tips and experiences. Is there a possibility in your state to earn CEUs for the preparation of HALS documentation? Please share any updates. Helen Erickson shared how easy this process has been in Arizona, especially given that the documentation is ultimately reviewed by the HALS office and transmitted to the Library of Congress if accepted. Barbara Wyatt mentioned that groups like NAPC

do not offer ASLA CEUs. They do offer AIA credits currently. Ali Hay discussed details of the process to convert ASLA credits to ASLA CEUs. Please see **Appendix A: Example of ASLA State Chapter Paperwork – for CEUs.**

3. New Business

- a. HALS at the ASLA EXPO ASLA has a separate area called "PPN Live" for anything Professional Practice Network-related such as HALS.
- b. HALS Coordinator Annual Report (Chris Stevens)
 - i. Chris Stevens thanked the HALS Subcommittee of the ASLA Historic Preservation Professional Practice Network and all of the HALS Liaisons and HALS documentation donors across the country. The small HALS program relies on professionals and volunteers to prepare HALS documentation for the everexpanding Library of Congress Collection.
 - ii. Only 4 Vacant Chapter HALS Liaison positions: Arkansas, Nebraska (Great Plains), Kansas (Prairie Gateway), and South Carolina. This is the lowest number of vacancies ever!
 - iii. There are only 3 states without any HALS documentation: Montana, North Dakota, New Hampshire. Kent Watson, Montana HALS Liaison, reports that he wishes to document Going-to-the-Sun Road for HALS soon.
 - iv. Summary of 2018 HALS Annual Report (HALS Liaison Survey Responses)

Chapter Highlights:

Arizona HALS projects were presented at the Arizona Historic Preservation annual meeting and at the Alliance for Historic Landscape Preservation meeting.

Boston knows this is a difficult time politically to push for HALS, but feels we need another push from ASLA advocacy to make HALS documentation part of federal or state funded projects.

v. **Florida** shares that their SHPO is always willing to meet to discuss historic landscapes, and even has included historic landscapes in its National Register program. Their SHPO addresses landscapes as Traditional Cultural Properties but does not address historic sites and districts as cultural landscapes. Their approach represents the archeological and architectural point of view.

Iowa is in the process of updating their chapter website with the recent National ASLA branding change, and this could provide an opportunity to introduce and expand on HALS.

Mississippi has presented HALS information with Mississippi State University Landscape Architecture students.

New Mexico held a chapter quarterly meeting, open to all members, at Los Poblanos Historic Inn and Organic Farm where attendees experienced an all-day educational site tour with a presentation of HALS information. Numerous coordination meetings regarding multiple projects were held this year with both the New Mexico SHPO and the New Mexico Historic Preservation Division's State and National Register Coordinator. HALS was also presented at the Center for

Southwest Research at the University of New Mexico in March 2018 as well as the New Mexico History Conference, sponsored by the Historical Society of New Mexico, in Alamogordo, NM, in April 2018. Her presentations focused on vernacular landscapes of the desert southwest, specifically on ranching and farming in the early 20th century.

Oklahoma State Foundation is funding the publication of HALS documentation produced by Dr. Charles Leider and his students for 18 Oklahoma historic landscapes in his Historic Landscape Architecture Preservation course. The book will be published by Arcadia this fall and used by the OK Department of Tourism to promote visits to historic landscapes to the sites throughout the state. The book will also be available locally in Oklahoma and nationally through Amazon. The book complements an earlier publication: *Oklahoma State University* also published by Arcadia Press and available through Amazon. This book is organized around the master plans prepared for the campus and the accomplishment of each master designer to the present.

Rhode Island works with the SHPO to coordinate at least one historic landscape workshop for the annual Historic Preservation Conference.

San Diego's HALS Committee is also composed of historians and planners who are not ASLA members. They are working with the Cultural Landscape Foundation (TCLF) to prepare a "What's Out There" weekend with a booklet and website. This work may then be reformatted to HALS Short Format historical reports.

Southern California presented HALS at a Cultural Landscape Workshop put on by the California Preservation Foundation, which some ASLA members attended, and they provided training last year. HALS presentations were made to several local interest groups and at a California Preservation Foundation workshop at the Los Angeles Arboretum.

Vermont has been preparing a database of historic landscapes in their state.

Washington, DC met with DC SHPO Kennedy informally at a recent DC Office of Planning meeting and sent a follow up letter advising him about DC HALS activity.

General Observations:

+Most HALS Liaisons meet with their Chapter's Executive Committee and share HALS updates in a mutually beneficial way.

+Some HALS Liaisons operate alone without any other HALS enthusiasts, volunteers, or a HALS committee. Building a community interested in historic landscape preservation is a great way to promote interest in HALS. Even if liaisons just email fellow chapter members and ask them to share all historic landscapes they know of in their state (with the landscape's name, address, coordinates, why it is significant etc.). Building a list or spreadsheet is a great way to build and leverage community interest.

+Meeting or communicating with your state or local SHPOs, preservation commissions, AIA chapters, historic societies, garden clubs, etc. is a great way to build a HALS community and promote historic landscape preservation. Many

HALS liaisons rely on non-landscape architects to assist with HALS documentation. Some SHPOs employ landscape architects, and in a few states the HALS liaison is a landscape architect from the SHPO.

+Everyone agrees the final acceptance and approval of the latest draft of the Secretary of the Interior's Historic Preservation Professional Qualification Standards - includes Historic Landscape Architects - is of the utmost importance to not only allowing landscape architects to compete for paid HALS mitigation documentation projects in every state but also will expand recognition and preservation of historic American landscapes.

+Folks have suggested that HALS be featured in Landscape Architecture Magazine (LAM) routinely - such as with a photo or drawing each month. Already, Ali Hay periodically prepares HALS fillers for empty space in LAM. We could work with her to select the image and promote certain landscapes or projects in these fillers.

+Interest in each annual HALS Challenge competition theme varies. The 2019 theme of Historic Streetscapes is very general and lends itself to reaching out to your SHPO or local preservation commissions to raise awareness of these often overlooked historic features.

+Every two years, Chris Stevens, NPS HALS and ASLA HALS Coordinator, provides a brief 15-minute HALS presentation to the ASLA Chapter Presidents Council at the ASLA Annual Meeting. In this way, all chapter presidents are introduced to HALS and the roll of their chapter's HALS liaisons.

+Many HALS liaisons suggested increased communication from NPS HALS, ASLA HALS, and among each other between ASLA chapters. We will be thinking of methods to improve communication such as a periodic HALS Liaison e-newsletter.

c. 2019 HALS Challenge

The **10th annual HALS Challenge** theme is *Historic Streetscapes*. Many cities have come to appreciate the cultural and commercial value of their historic streets. Main Street Programs across the nation have encouraged the revitalization of commercial historic districts, and now the Complete Streets movement is sweeping the design world. What makes your favorite historic street(s) unique? Does your local Historic Preservation Commission protect the streetscape characteristics and features of historic districts along with the contributing buildings? You may increase historic landscape awareness with your local governments and preservation commissions by documenting historic streetscapes for HALS and illuminating these significant parts of America's circulatory system.

People from every state are hereby challenged to complete at least one HALS short format history to document historic thoroughfares.

Please choose an individual street or a contiguous network or grid of streets to document and pay particular attention to the: benches, bollards, bus stops, circles, context, crosswalks, curbing, drainage, facades, fencing, festivals, fountains, gutters, islands, lampposts, medians, meters, monuments, paving, pedestrian malls, parades, parking, planters, plazas, porches, public art, ramps, setbacks, sidewalks, signage, significance, squares, steps, stoops, street trees, traffic lights, trolley tracks, utilities, etc.

d. 2018 HALS Challenge

The theme for the 9th annual HALS Challenge was *Memorialization, Commemorating the Great War*. Thank you to all entrants for expanding the HALS collection and raising awareness of the historic landscapes they documented. Veterans Day 2018 marks the centennial of the armistice that ended World War I - *The Great War* or *The War to End All Wars*. Thank you for helping us recognize this significant anniversary by documenting the traditional monuments and civic memorials that honored the Americans who fought and died in the first world war. Again *LAM* graciously provided full page ads for the 2018 HALS Challenge in the April and May Issues. HALS received 17 entries from 12 states.

i. Announcement of 1st, 2nd, and 3rd place, and Honorable Mention prizes, a brief description of each project, and presentation of certificates (All 17 entries are listed below).

4. Other Business / Open Discussion

- a. Paul Dolinsky announced that 2019 will mark the 50th Anniversary of HAER, and 2020 will mark the 20th Anniversary of HALS. Plans are currently being made to recognize the half-century anniversary of HAER. Industrial or engineering sites are often cultural landscapes. HAER looks at them through an engineer's lens.
- b. Paul Dolinsky announced that the J.M. Kaplan Fund is sponsoring HABS/HAER/HALS documentation of 22 civil rights sites in Alabama. This effort includes helping to establish a historic preservation program at Tuskegee University. Students would be involved in the documentation. The ultimate goal is a GIS story map. The Edmund Pettus Bridge is a National Historic Landmark, and this new documentation can be used to expand the list of related resources in that nomination.
- c. Graham Sones announced he will be preparing HALS Documentation of the 12-13-acre Maywood, the historic Mayo Estate in Rochester, Minnesota: http://history.mayoclinic.org/tours-events/mayowood.php

Workshop Description:

This workshop introduces professional Landscape Architects to the Historic American Landscapes Survey (HALS) leading the growing public interest in recording total environments (cultural landscapes). While LAs were omitted as qualified professionals from the National Historic Preservation Act, this workshop instructs participants to capably collect, archive, and disseminate historic preservation documentation, provide client guidance in recording to federal standards, make the documentation understandable and publically accessible.

One hour of classroom instruction prepares participants with the fundamental understanding of the HALS recording process and the procedures of preparing documentation for submittals to the Library of Congress. Three hours of fieldwork guides participants through the process of identification of landscape characteristics and features and how to prepare submittals to the Library of Congress.

Knowledge gained by participants of this course will help to preserve Florida heritage landscape resources, thereby enhancing the health, safety and welfare of our citizens of Florida and its visitors.

10 minutes: ASLA's partnership with the National Park Service and Library of Congress to establish HALS

60 minutes: Identifying historic landscape characteristics and features

60 minutes: Producing measured and interpretive drawings of historic landscapes

30 minutes: Photographing historic landscapes

20 minutes: Bringing it all together as a HALS submittal 10 minutes: Questions and answers and wrap-up

Presenter Biography:

David Driapsa, FASLA, is a historical landscape architect and the principal of David J Driapsa Landscape Architecture of Naples, Florida, from where he is a consultant working on an array of projects nationwide. David is a Fellow of the American Society of Landscape Architects, recognized nationally in historic landscape preservation as well as for contemporary planning and design. He led the national expansion of the Historic American Landscapes Survey for ASLA in its partnership with the National Park Service and Library of Congress, he founded and continues to spearhead the HALS program in Florida, and he serves on the Board of Directors of the international Alliance for Historic Landscape Preservation.

The instructor has worked on many exceptionally significant landscapes, including the Mount Lebanon Shaker Village, New York; the Spanish Colonial village of Chimayo, New Mexico; the segregated African American community of Smokey Hollow, Florida; the Olmsted Brothers' "lost village" of Boca Grande, Florida; the winter estate of Thomas Edison; and projects for the State of Florida and the National Park Service.
